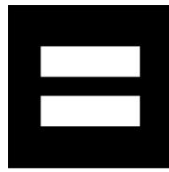

Dear President Trump,

As parents of transgender children, we were heartbroken and scared when we learned that your Administration's Department of Justice had dropped its objections to a nationwide hold on Obama era protections for transgender students. You promised to be a president for all Americans, but less than 48 hours after Jeff Sessions was confirmed as Attorney General, the Department of Justice took a concrete step to undermine equality for the LGBTQ community.

All students deserve equal access to a safe, welcoming school and a high quality education no matter who they are and where they live. This is the value at the center of our nation's education policies and civil rights laws and it is a principle espoused by the 2016 guidance issued by the U.S. Departments of Justice and Education seeking the fair and respectful treatment of transgender students in our nation's schools and colleges.

In communities across this country, thanks in part to this guidance, we have seen transgender students of all ages seamlessly welcomed into their schools by friends and faculty. We have witnessed, first hand, the success of inclusive policies that reflect the overwhelming consensus from health professionals like the American Academy of Pediatrics and the American Psychological Association that affirming our children's gender identities is imperative. And, as more transgender young people come out, the guidance adopted by the Obama Administration continues to offer teachers and administrators a helpful tool in building learning environments that allow all students to flourish.

Sadly, there remain some in our school environments who still choose to target our children for mistreatment and violence. Many of us find ourselves in school districts or states that are considering or have already adopted policies that single-out transgender students for discrimination. We know the devastating impacts these policies can have. 75 percent of transgender young people report feeling unsafe in school. One study found that more than fifty percent of transgender youth have attempted to commit

suicide at least once in their lifetime. These policies are wrong, they hurt our children, and they violate the principle of equal protection.

We could not be prouder of our children. They have shown our families and the world a courage and authenticity that has filled our hearts and opened our minds. Their lives enrich our homes, our schools, and our neighborhoods. We have seen many recent, pivotal changes that signal a bright future. The Boys Scouts of America recently changed its policy to include transgender boys in their organization, a move that mirrors a similar longstanding policy by the Girl Scouts of America welcoming transgender girls. The cover of National Geographic magazine featured a bright eyed, brave young transgender girl. In contrast to these positive social changes, the decision by your Administration to undermine our legal progress is mean-spirited and potentially threatens the wellbeing of our beloved children.

Like all parents, all we want is for our children to be healthy, safe, and loved. No young person should wake up in the morning fearful of the school day ahead. When this guidance was issued last year, it provided our families -- and other families like our own across the country -- with the knowledge and security that our government was determined to protect our children from bullying and discrimination. Please do not take that away from us. We ask you to preserve the guidance and instruct the Departments of Justice and Education to robustly pursue every opportunity to enforce Title IX on behalf of transgender students.

Dear President Trump,

As parents of transgender children, we were heartbroken and scared when we learned that your Administration's Department of Justice had dropped its objections to a nationwide hold on Obama era protections for transgender students. You promised to be a president for all Americans, but less than 48 hours after Jeff Sessions was confirmed as Attorney General, the Department of Justice took a concrete step to undermine equality for the LGBTQ community.

All students deserve equal access to a safe, welcoming school and a high quality education no matter who they are and where they live. This is the value at the center of our nation's education policies and civil rights laws and it is a principle espoused by the 2016 guidance issued by the U.S. Departments of Justice and Education seeking the fair and respectful treatment of transgender students in our nation's schools and colleges.

In communities across this country, thanks in part to this guidance, we have seen transgender students of all ages seamlessly welcomed into their schools by friends and faculty. We have witnessed, first hand, the success of inclusive policies that reflect the overwhelming consensus from health professionals like the American Academy of Pediatrics and the American Psychological Association that affirming our children's gender identities is imperative. And, as more transgender young people come out, the guidance adopted by the Obama Administration continues to offer teachers and administrators a helpful tool in building learning environments that allow all students to flourish.

Sadly, there remain some in our school environments who still choose to target our children for mistreatment and violence. Many of us find ourselves in school districts or states that are considering or have already adopted policies that single-out transgender students for discrimination. We know the devastating impacts these policies can have. 75 percent of transgender young people report feeling unsafe in school. One study found that more than fifty percent of transgender youth have attempted to commit

suicide at least once in their lifetime. These policies are wrong, they hurt our children, and they violate the principle of equal protection.

We could not be prouder of our children. They have shown our families and the world a courage and authenticity that has filled our hearts and opened our minds. Their lives enrich our homes, our schools, and our neighborhoods. We have seen many recent, pivotal changes that signal a bright future. The Boys Scouts of America recently changed its policy to include transgender boys in their organization, a move that mirrors a similar longstanding policy by the Girl Scouts of America welcoming transgender girls. The cover of National Geographic magazine featured a bright eyed, brave young transgender girl. In contrast to these positive social changes, the decision by your Administration to undermine our legal progress is mean-spirited and potentially threatens the wellbeing of our beloved children.

Like all parents, all we want is for our children to be healthy, safe, and loved. No young person should wake up in the morning fearful of the school day ahead. When this guidance was issued last year, it provided our families -- and other families like our own across the country -- with the knowledge and security that our government was determined to protect our children from bullying and discrimination. Please do not take that away from us. We ask you to preserve the guidance and instruct the Departments of Justice and Education to robustly pursue every opportunity to enforce Title IX on behalf of transgender students.

The Departments also stated, “This guidance does not add requirements to applicable law.” I disagree. The Departments altered existing law through changes in policy to create a protected class under Title IX. The Departments used the Executive branch to amend a congressionally passed statute (20 U.S.C. § 1681(a)) to create gender identity as a protected class. Dear Colleague:

The purpose of this guidance is to inform you that the Department of Education and the Department of Justice are withdrawing the statements of policy and guidance reflected in:

- Letter to Emily Prince from James A. Ferg-Cadima, Acting Deputy Assistant Secretary for Policy, Office for Civil Rights at the Department of Education (OCR) dated January 7, 2015; and,
- Dear Colleague Letter on Transgender Students jointly issued by the Civil Rights Division of the Department of Justice (“DOJ”) and OCR dated May 13, 2016.

These guidance documents take the position that the prohibitions on discrimination “on the basis of sex” in Title IX of the Education Amendments of 1972 (“Title IX”), 20 U.S.C. § 1681 et seq., and its implementing regulations, see, e.g., 34 C.F.R. § 106.33, require access to sex-segregated facilities based on gender identity rather than biological sex.

This interpretation has given rise to significant litigation regarding school restrooms and locker rooms. The U.S. Court of Appeals for the Fourth Circuit concluded that the term “sex” in the regulations is ambiguous and deferred to what the court characterized as the “novel” interpretation advanced in the guidance. That case is currently pending before the Supreme Court. By contrast, a federal district court in Texas held that the term “sex” unambiguously refers to biological sex and that, in any event, because the guidance was “legislative and substantive,” formal rulemaking should have occurred prior to the adoption of any such policy. The Texas court preliminarily enjoined enforcement of the interpretation, and that injunction currently remains in effect.

---

In addition, over the past two years, school administrators, parents, and students have expressed varying views on the legal issues arising in this setting. They have also struggled to understand and apply the statements of policy and guidance in the two documents identified above.

In these circumstances, OCR and DOJ have decided to withdraw and rescind the above-referenced guidance documents in order to further consider the legal issues involved. The Departments thus will not rely on the views expressed within them.

Please note that the withdrawal of these guidance documents does not diminish the protections from bullying and harassment that are available to

---

all students. Schools must ensure that transgender students, like all students, are able to learn in a safe environment.

This guidance does not add requirements to applicable law, but provides information about how OCR and DOJ will proceed in developing the appropriate approach for determining whether covered entities are complying with their legal obligations in this context. We have a responsibility to protect every student in America and ensure that they have the freedom to learn and thrive in a safe and trusted environment. This is not merely a federal mandate, but a moral obligation no individual, school, district or state can abdicate. At my direction, the Department's Office for Civil Rights remains committed to investigating all claims of discrimination, bullying and harassment against those who are most vulnerable in our schools.

The guidance issued by the previous administration has given rise to several legal questions. As a result, a federal court in August 2016 issued a nationwide injunction barring the Department from enforcing a portion of its application. Since that time, the Department has not enforced that part of the guidance, thus there is no immediate impact to students by rescinding this guidance.

This is an issue best solved at the state and local level. Schools, communities, and families can find – and in many cases have found – solutions that protect all students.

I have dedicated my career to advocating for and fighting on behalf of students, and as Secretary of Education, I consider protecting all students, including LGBTQ students, not only a key priority for the Department, but for every school in America.

Dear President Trump:

We write to urge you to reconsider your decision to rescind important Title IX guidance detailing schools' obligation to protect transgender students from discrimination. The guidance set forth by both the Departments of Education and Justice in May 2016 has helped educational institutions answer common, practical questions concerning this population of students while maintaining compliance with the law. Further, we ask you and members of your administration to meet with transgender students and their families who have relied on this guidance for a safe learning environment and hear their stories about what it means to be transgender in school.


Hundreds of thousands of transgender students live and attend school in every part of our country. A recent report by the Williams Institute estimated there are over 350,000 transgender teens and young adults between ages 13 and 24 in America. Studies show that transgender students are healthy and successful when they receive support and fair treatment, but too many of these students face discrimination. The 2015 U.S. Transgender Survey found that more than three-quarters (77%) of respondents who identified or were perceived as transgender in K-12 school had one or more negative experiences, such as being verbally harassed, prohibited from dressing according to their gender identity, or physically or sexually assaulted. Singling out transgender students by excluding them from school facilities and forcing them to use separate facilities is a real and harmful form of discrimination that causes humiliation and puts students at risk for bullying and health problems.

The federal guidance issued in May 2016 pertaining to transgender students reflects over a decade of case law and proven best practices from schools around the country. The Departments issued this guidance at the request of educators across the country seeking clarification about how to best comply with existing laws. National leaders in education - including the leading associations of teachers, principals, pediatricians, and school counselors and psychologists - supported this clarification.

Title IX provides transgender students the right to equal treatment in accordance with their gender identity. Unfortunately, rescinding this guidance only serves to confuse school administrators and take away a vital tool for students and their families who want to be treated with dignity and respect. Further, this action sends the wrong message - a very dangerous message - to transgender youth and their peers.

For these reasons, we urge you to reverse your decision and reinstate the Title IX guidance. Furthermore, we urge you, the U.S. Attorney General Jeff Sessions, and U.S. Department of Education Secretary Betsy DeVos to meet with transgender students and their families to hear firsthand about their school experiences. Thank you for your prompt attention to this matter.
