Dear Director Wray and Acting Director Lombardo,

We write to urge you to take appropriate steps to promote public safety and responsible firearm ownership in the wake of surging gun sales across the country. According to recent news reports, gun shops and ammunition dealers have experienced a massive uptick in purchases, particularly from first-time buyers experiencing coronavirus-related anxiety. We are concerned that this surge is overwhelming the National Instant Criminal Background System (NICS), and that federal firearms licensees (FFLs) need new guidance to effectively handle it.

All gun sales by FFLs require a background check through NICS or a state point of contact unless the buyer already has a qualifying permit.³ Most background checks are completed in a matter of minutes, but some take longer when NICS must contact state and local law enforcement to examine additional records.⁴ If a background check for a particular individual is not completed within three business days, FFLs may choose to transfer the gun(s) to that individual anyway in what is known as a "default proceed." In 2018, more than 270,000 background checks were not completed within three business days, resulting in more than 4,800 gun transfers to individuals whose background checks ultimately revealed a gun-ownership prohibition.⁶ In particular, a 2016 report by the Government Accountability Office found that it

takes the Federal Bureau of Investigation (FBI) longer to complete background checks for domestic violence convictions than for other prohibiting criteria.⁷

Even absent a public health emergency, law enforcement does not always have enough time to accurately determine pre-sale whether someone is a prohibited buyer. The tragic 2015 shooting at Charleston's Mother Emanuel AME Church demonstrates this problem. After "a failure by local prosecutors to respond to a [NICS] request for more information about his case," the shooter "exploited the three-day waiting time that has allowed thousands of prohibited buyers to legally purchase firearms over the past decade."

We fear that a drastic increase in gun sales in response to the coronavirus pandemic could overwhelm NICS and allow prohibited individuals to obtain firearms through "default proceeds." Local law enforcement agencies and courts across the country suddenly face staffing shortages and resource challenges that may prevent them from providing timely responses to NICS requests. We believe it is essential that your agencies issue guidance to FFLs about their ongoing responsibilities under the law and the tools with which they can safely operate their businesses during this unprecedented public health emergency.

To that end, we request that you immediately take the following steps to protect public safety:

- 1. **Default Proceeds Guidance to FFLs**: The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) should issue guidance alerting FFLs that background checks are likely to take longer than three business days for NICS to complete during the pandemic, especially in states where state employees are working remotely. Moreover, guidance should urge FFLs to wait for NICS to complete those background checks before transferring firearms, and remind FFLs of their obligations under 18 U.S.C. §§ 922(b), (d), and (x) not to transfer firearms to any person whom they know, or have reasonable cause to believe, is prohibited from possessing a firearm. Additionally, it is critical that FFLs continue to maintain all required records, including those related to inventory, sales, and transfer. We believe that this guidance is necessary to prevent "delayed denials," when prohibited purchasers buy guns through default proceed.
- 2. **Default Proceeds Data Collection**: The FBI should collate data on the number and percentage of background checks that have taken longer than three business days to complete in the past three months, broken down by week. Within one week of receipt of this letter, the FBI should provide Congress with this data and with a reasonable timeframe for NICS to complete background checks during the pandemic.
- 3. **Emergency Request for Records Retention**: Under current regulations, all incomplete background check records must be deleted from NICS within 90 days. ¹⁰ Because the

pandemic and recovery may last longer than 90 days, the FBI should issue an emergency directive to maintain all background-check information related to transactions with an "open" status for 90 days beyond the current state of emergency as the president proclaimed under the National Emergencies Act.¹¹

- 4. **Require a Search of N-DEx Database for All Background Checks**: The FBI's Criminal Justice Information Services Division maintains the National Data Exchange (N-DEx) database, which maintains records not included in background checks such as incident and case reports. ¹² The FBI should utilize this database and include a search of N-DEx records for investigations into NICS background checks that receive a "delayed" disposition. States should be encouraged to incorporate N-DEx records into their background check processes as well.
- 5. Safe Storage Directive to FFLs: With millions of Americans now working and learning from home, safe gun storage is of even greater importance to protecting families, neighbors, and children. ATF should issue guidance reminding FFLs of their legal obligation under 18 U.S.C. § 922(z) to provide a gun lock or a safe storage device with the transfer of any new handgun, as well as their responsibility under existing regulations to provide purchasers with written notification about federal prohibitions on juveniles accessing handguns. Guidance should also recommend that FFLs provide their customers especially first-time gun buyers with information about the risks and responsibilities of gun ownership and about safe storage practices.

We know that the FBI and ATF remain committed to protecting public safety during this pandemic, including by preventing an increase in unintentional shootings, firearm suicides, and other forms of gun violence. We appreciate your personal attention to these requests and look forward to your prompt reply. Please let us know how we can help you protect our nation during the challenging times ahead.

The National Shooting Sports Foundation (NSSF) is America's trade association for the firearm, ammunition, hunting and recreational shooting sports industry. Our over 9,000 member companies include federally licensed manufacturers, distributors and retailers of firearms and ammunition products. On behalf of our members nationwide, I am writing to thank you for your leadership and the ongoing efforts of your agencies to keep our nation safe and secure during the COVID-19 (Coronavirus) pandemic.

Record Number of Firearm Purchases Straining NICS

During this time of crisis, Americans are concerned for their safety, and record numbers have turned to their Second Amendment rights to keep and bear arms. Food, water, shelter and medical care are paramount for survival, but so too is the ability for an individual to defend his or herself, their family, as well as their home, business and property. NSSF shares concerns expressed by others that this increase in demand for firearms has strained the crucial National Instant Criminal Background Check System (NICS). There is also a sense of frustration among federally licensed firearm retailers that there has not been enough communication and guidance for retailers who are committed to remaining in compliance with all applicable laws and regulations during this unprecedented situation.

The firearm and ammunition industry respects the existing laws and regulations and seeks increased guidance on how to comply with new restraints and requirements imposed by state and local authorities seeking to contain this virus. We know that NICS and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) have a clear obligation to enforce the law under their statutory authority. However, we reject arguments made by some elected officials

and advocacy groups that NICS and ATF should illegally impose policy changes that extend beyond the clear legal requirements.

The top concern for those in our industry is how to handle the small percentage of NICS checks that result in a "Delay" response. NSSF is aware that the COVID-19 crisis is creating a perfect storm for NICS in terms of these delays. First, there is a significant increase in background check volume, putting pressure on the system. Second, certain state offices are working remotely or with reduce staffing, creating uncertainty about whether the state is "open," for purposes of calculating the three-business days ("Brady Transfer Date") pursuant to 18 USC § 922(t)(B)(ii). Third, the current situation is making it difficult for NICS examiners to investigate delayed checks. We understand delayed checks are currently about 58,000 nationwide, down from as many as 80,000.

NSSF has proactively shared NICS communications with retailers that the system is currently under enormous strain and that they may choose, as always, whether to decline a sale without an affirmative NICS response. However, without an Act of Congress, it is inaccurate to state that transferring a firearm after the three-business day period provided by Section 922(t)(B)(ii) and 27 CFR 478.102(a)(2) is illegal. All states offices remain open, whether their personnel are working remotely or in reduced capacities. No state is closed as if it were a state holiday. The guidance that would most help the retailer community right now would be to fully explain how the Brady Transfer Dates are being calculated in accordance with the law and what the recommendations are for situations in which the transfer dates are farther out than the 30-day period for which the NICS check is valid.

NSSF urges ATF and NICS to reject politically motivated pressure to exceed statutory authority and promulgate regulations with no legal authority, or to pull resources away from core functions of protecting public safety in order to issue reports on background checks. No existing statute allows for extending the records retention beyond 90 days for NICS checks. NICS does caution on its website that "if the FFL transfers the firearm, the FFL must mark 'No resolution was provided within three business days' on line 21d of the ATF Form 4473." Issuing an emergency directive that runs counter to existing regulations would be a violation of the Administrative Procedures Act.

We understand the challenges facing ATF and NICS during this crisis. NSSF is working hard to urge Congress to provide ATF and NICS with the enhanced resources each needs to comply with the law, including the three-business day transfer date stated in the existing law and regulation. NSSF was the leading advocacy group urging support for the bipartisan Fix NICS Act signed into law by President Trump. The law was named after NSSF's successful FixNICS® campaign that has changed the law in 16 states to submit to NICS disqualifying records establishing that someone is a prohibited person under current law. NSSF's efforts have resulted in an over 240% increase in disqualifying mental health adjudications submitted to NICS.

Now is the time to provide more resources for NICS and ATF. It is not the time to divert limited existing resources to suit the requests of those with alternative agendas.

Industry's Dedication to Safe Storage and Use Practices

For our part, the firearm and ammunition industry is more dedicated than ever to ensuring the safe and legal purchase, use and storage of our products. We are reaching out to new gun owners, as well as the existing firearm-owning community, through articles that review the rules of firearm safety and secure storage, and through video messages and interviews that emphasize the resources new owners should be aware of and rely on.³

For decades now, manufacturers have included a free locking device with every new firearm shipped from the factory. In addition, NSSF, on behalf of our industry and through our award-winning Project ChildSafe® campaign, has distributed at no cost over 38 million firearm safety education kits that include a cable-style gun lock to our more than 15,000 law enforcement partners in all 50 states and U.S. territories for distribution into their local communities.⁴

NSSF also works to support legislation such as the bipartisan FFL Protection Act (S.1788/H.R.2179), which would strengthen and enhance criminal penalties for thefts of firearms from licensees, and build on Operation Secure Store®, our partnership with ATF to match reward offers for such thefts and to educate FFLs on the steps they can take to reduce the chance that guns will be stolen from them during a burglary or robbery.

In addition, NSSF is working to help keep open shooting ranges, with appropriate social-distancing measures in place. Both public and private ranges are essential to public safety, as they are where firearm safety education is taught to new and inexperienced gun owners. Ranges are also where law enforcement officers typically train to be proficient with their duty weapon and where members of the military train before they deploy to defend our nation.

The firearm and ammunition industry is present in every community. We know first-hand the importance of ensuring that families are able to focus on what's important right now: following government guidance to help stop the spread of this deadly virus. The last thing an American should be worrying about is how to make sure they are physically safe. To that end, NSSF and the firearm and ammunition industry thank ATF and NICS for the tremendous work underway to allow federally licensed firearms licensees to remain open, while abiding by the important social-distancing guidelines.




What type of background checks system do you use?




Are you experiencing a higher share of delays than usual?







I hope you are staying healthy. I wanted to let you know that NSSF is speaking w/ CJS approps staff to encourage them to include \$20M in supplemental funding for NICS in Covid 19 Phase IV bill

An effective and properly functioning NICS is vital to the health of the firearm industry and the ability of our retail members to transfer firearms to law abiding Americans exercising their Second Amendment rights. We have been advocated for the President's FY21 budget request of \$19 9mm over FY20 enacted levels for NICS for additional personnel and IT needs to support their important mission. The unprecedented surge demonstrates the urgent need for NICS to receive this additional funding now, before FY 21 CJS can be enacted sometime next year One of the side benefits of doing the plus up now is that the supplemental funding in Covid-19 is not subject to 302 allocation caps. This will free up \$20M in FY 21 for other priorities

We have spoken to members on Senate CJS approps and Chairman Moran's personal office staff (George Redden), as well as Republican House CJS approps staff (Stephanie Gadbois). The feedback has been very positive. They are willing to e pedite the "plu up," but have told u that they need to hear from the Admini tration that it i in upport

I wanted to let you know that I have spoken w/ Brian McCormick at OMB about this issue He may be touching base with you in the near future. One example of how the funding could put to good use that I discussed with Brian is that it could help address the issue of arrest records being submitted to NICS without a disposition (about 16%) which is one of the main reason checks go into Delay status. In a call a few weeks ago Mark mentioned to me the need for about \$13-15M over 3 years to implement an enterprise solution to automate the matching of arrest and disposition records See AG' Fix NICS report at 19.
