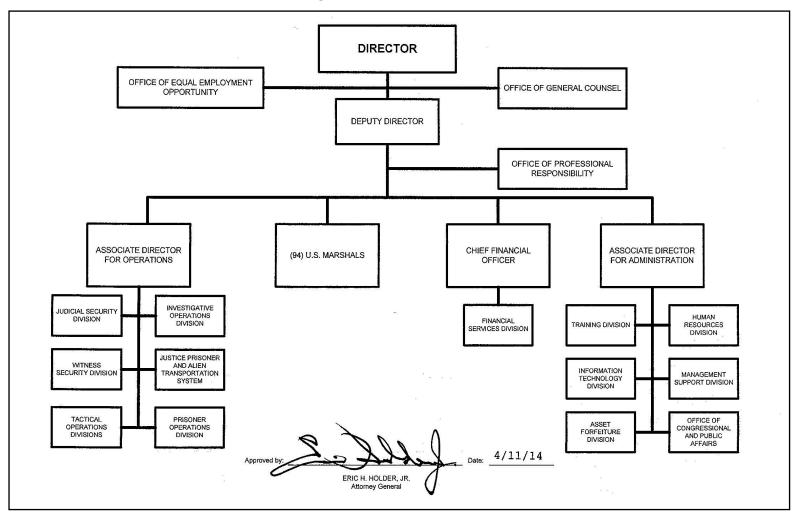
Organizational Chart

2 FY 2024 Program Realignment - Detention Operations This request realigns 42 positions and \$33,377 for detention operations and management from the FPD appropriation to the USMS Salaries and Expenses appropriation. These resources support program oversight of detention contracts, process improvements in detention that are now provided by Capture, and IT infrastructure modernization. Currently, Prisoner Operations Division personnel is funded out of two appropriations. This realignment will fund all USMS personnel in the Salaries and Expenses appropriation.	-42	-42	-33,377
3 FY 2024 Program Realignment - Int'l Extraditions This request realigns \$3,000 for international extraditions to the FPD appropriation from the USMS S&E appropriation. The USMS is the Federal government's primary agency tasked with returning international fugitives to the United States safely and securely. The extradition mission is a transportation function and the USMS believes it is appropriate to fund extraditions through the FPD appropriation, with the other detainee and prisoner air transportation costs.	0	0	3,000

Per the The House Report associated with the Departments of Commerce, Justice, Science, and Related Agencies Appropriations Bill, 2023, page 72: The USMS is directed to continue to submit monthly reports on individuals in the detention system, as directed in the explanatory statement accompanying the fiscal year 2022 Appropriations Act, and to anticipate funding needs so as to avoid funding shortfalls or a need for emergency reprogramming.
